Towards an EU climate-resilience roadmap for sustainable tourism: NaTour4CChange project policy & networking event

CONCEPT NOTE

1. Background and policy context

Climate change is rapidly reshaping tourism across Europe. Heatwaves, water scarcity, biodiversity loss, coastal erosion, and extreme weather events increasingly affect tourism destinations, local communities, SMEs, infrastructure, and regional economies. Indeed, the Mediterranean is among the most climate-vulnerable regions in Europe.

The **EU Sustainable Tourism Strategy** offers a unique opportunity to strengthen the European policy framework for a greener, more resilient, and territorially balanced tourism model.

The Interreg Euro-MED project [NaTour4CChange](#) brings together 5 Mediterranean regions and 7 tourism coastal destinations to test and implement **climate adaptation and mitigation strategies for tourism, Nature-based Solutions (NbS)** and **innovative multi-level governance models**.

2. Objectives of the session

The event aims to position project experiences and lessons learned as a concrete contribution to the implementation phase of the EU Sustainable Tourism Strategy¹ and the post-2027 EU policy agenda.

It will explore how EU tourism policies can better integrate climate resilience **through territorial tourism governance, NbS and investment frameworks** aligned with:

- The EU climate agenda (adaptation and mitigation frameworks)
- EU Cohesion policy monitoring and funding systems
- The priorities and implementation mechanisms of the new EU Sustainable Tourism Strategy
- The role of Mediterranean macro-regional strategies and sea-basin initiatives

More specifically, the event will:

1. Identify priority EU policy instruments supporting climate adaptation and resilience in tourism regions and destinations.
2. Discuss how to mainstream resilience into tourism strategies, spatial planning, EU nature conservation and restoration frameworks (such as the EU Biodiversity Strategy, the Nature Restoration Regulation...), maritime, coastal and islands related policies, while ensuring coherence with funding programmes for the 2027–2032 period, building on the concrete tested approaches and tools developed by NaTour4CChange.
3. Underline the role of Nature-based Solutions (NbS) as synergetic, cross-cutting interventions capable of delivering multiple societal, environmental, and climate objectives within the implementation of the new EU Sustainable Tourism Strategy*.
4. Explore governance models and collaborative platforms enabling effective multi-level coordination (destination-regional-EU) and cross-sector cooperation (tourism, environment, transport, SMEs), with particular reference to the Regional Coordination Unit (RCU) model tested in the project.
5. Address monitoring and indicators:
 - How to define operational climate resilience indicators for tourism in line with the new EU Tourism Strategy*.
 - How to align regional and destination-level monitoring systems with EU climate, cohesion, and tourism performance frameworks.
6. Translate EU policy priorities into implementable and fundable actions for regions, destinations, and tourism SMEs, including operational pathways and financing mechanisms to replicate and scale up tested Nature-based Solutions and governance approaches.
